Systemwide General Education (SWGE) Timeline for Updates to Master Course Lists (MCLs)

- We will email Chief Academic Officers in late October about updating the SWGE course lists for the *next* Academic Year (Fall '26/Spring '27)
- Institutions have until mid-January to finalize their MCLs with us
- All (26) updates go through the Systemwide General Education Council for verification (January and February meetings)
- Institutions are notified about verification of courses by March 1



Systemwide Associate Degrees



Systemwide Associate Degrees (“SWADs”)

- Elementary Education (PK-6)
 - Approved June 2023
 - Effective Fall 2024 (AY 2025)
- Business Administration, Management, & Operations; Computer Science; Pre-Bachelor of Science in Nursing; and Pre-Social Work
 - Approved June 2024
 - Effective Fall 2025 (AY 2026)
- All require universities to apply 60 credit hours to the corresponding baccalaureate degrees if SWAD was completed



Systemwide Associate Degrees

- All SWADs require specific courses to be taken from the community college to fulfill general education requirements
 - (so that all 60 hours can be applied to the associated bachelor's program)

SYSTEMWIDE TRANSFER DEGREES

Systemwide transfer degrees provides pathways from any Kansas public community college offering an associate degree in an approved program to any Kansas public university offering a baccalaureate degree in that program. To date, the Regents have approved pathways in five programs that are among the most popular transfer programs for students in the system - **Business, Computer Science, Elementary Education, Pre-Bachelor of Science in Nursing** and **Pre-Social Work**.

Each pathway identifies courses/credit hours taken at the community college level and reflects the [Kansas Board of Regents \(KBOR\) General Education framework buckets](#). The courses will transfer to any public university as the first sixty hours toward the articulated degree. The remaining credit hours at the universities are the required courses to complete the baccalaureate degree.

Credit for Prior Learning Board Policy

4. CREDIT FOR PRIOR LEARNING

.....

f. Each Kansas public postsecondary educational institution shall follow the requirements set forth in the Kansas Credit for Prior Learning Guidelines when evaluating and awarding credit for prior learning. These Guidelines shall provide for:

- i. specifications for awarding credit for learning gained outside a traditional academic environment for the state universities, community colleges, technical colleges, Washburn University and Washburn Institute of Technology;
- ii. consistency with state and federal law, Board policies, applicable accreditation standards;
- iii. a consistent and transparent means for students to advance toward a degree or credential;
- iv. annual review for updates by the Kansas Credit for Prior Learning Task Force

Credit by Exam (A Subset of CPL)

b. Except for exams with alternative scores set under paragraph c, each state university shall award:

i. Credit for all Advanced Placement (AP) examination scores of three (3) or above for the equivalent course or courses at their institution.

ii. Credit for all College-Level Examination Program (CLEP) examination scores at or above the American Council of Education's (ACE) credit-granting recommended score of 50 for the equivalent course or courses at their institution.

iii. Credit for all International Baccalaureate (IB) examination scores of four (4) or above on Higher Level (HL) exams and Standard Level (SL) exams for the equivalent course or courses at their institutions.

iv. Credit for all Cambridge International (CI) examination scores of E or above on Advanced Levels (A Levels) exams and e or above on Advanced Subsidiary Level (AS Levels) exams when evaluated for the equivalent course or courses at their institution.



Credit by Exam

AP EXAM SCORES

With the exception of five exams, each state university shall award credit for all AP exam scores at 3 or above for the equivalent course(s) at their institution. (For a list of these courses, please refer to the institution's website.) The following exams require scores above 3 for credit to be awarded.

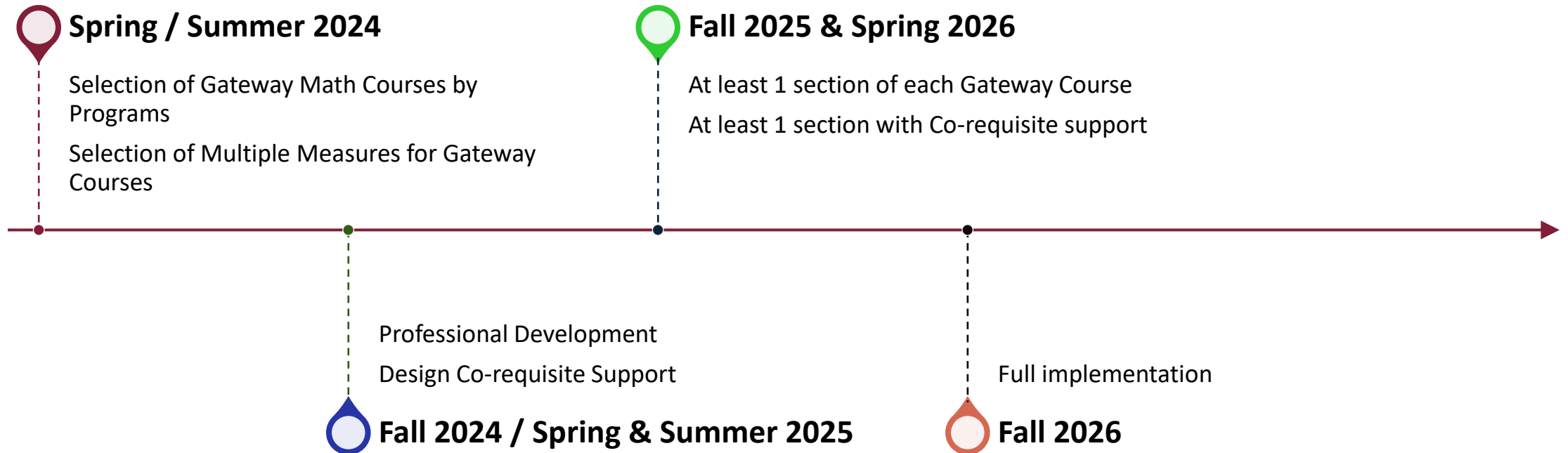

Reverse Transfer



Process of retroactively granting associate degrees to students who have not completed the requirements of an associate degree before transferring from a Kansas community college or technical college to a Kansas public university.



All community college, technical college, and university presidents signed the systemwide reverse transfer agreement in May 2014, which became effective in Fall 2014. Institutions must follow the “Reverse Transfer Procedures” document to support the goal of increasing the number of credential holders in Kansas as part of the Board’s strategic plan.



Reverse Transfer Procedures

- Identify eligible students with a minimum of 15 credit hours from a single Kansas community or technical college after application to the university.
 - If the university awards an applicable associate degree, further evaluation of the student's transcripts may be necessary to determine which institution should award the associate degree.
 - If the student has fewer than 30 hours from a single community college, the university may award the appropriate associate degree (if offered)
 - If the student has at least 30 hours from a single community college, the university must use the procedures for Reverse Transfer.

Reverse Transfer Procedures

- Inform eligible students about reverse transfer during application or their first semester at the university, with a statement about FERPA rights and the choice to **opt in**.
- Implement email campaigns, pop-up menus in student information systems, or other effective means of obtaining student opt-ins.
- Monitor students who have opted in to reverse transfer and, upon completing 60 credit hours, begin the referral process of sending transcripts to the appropriate community or technical college using the National Student Clearinghouse starting fall 2025.

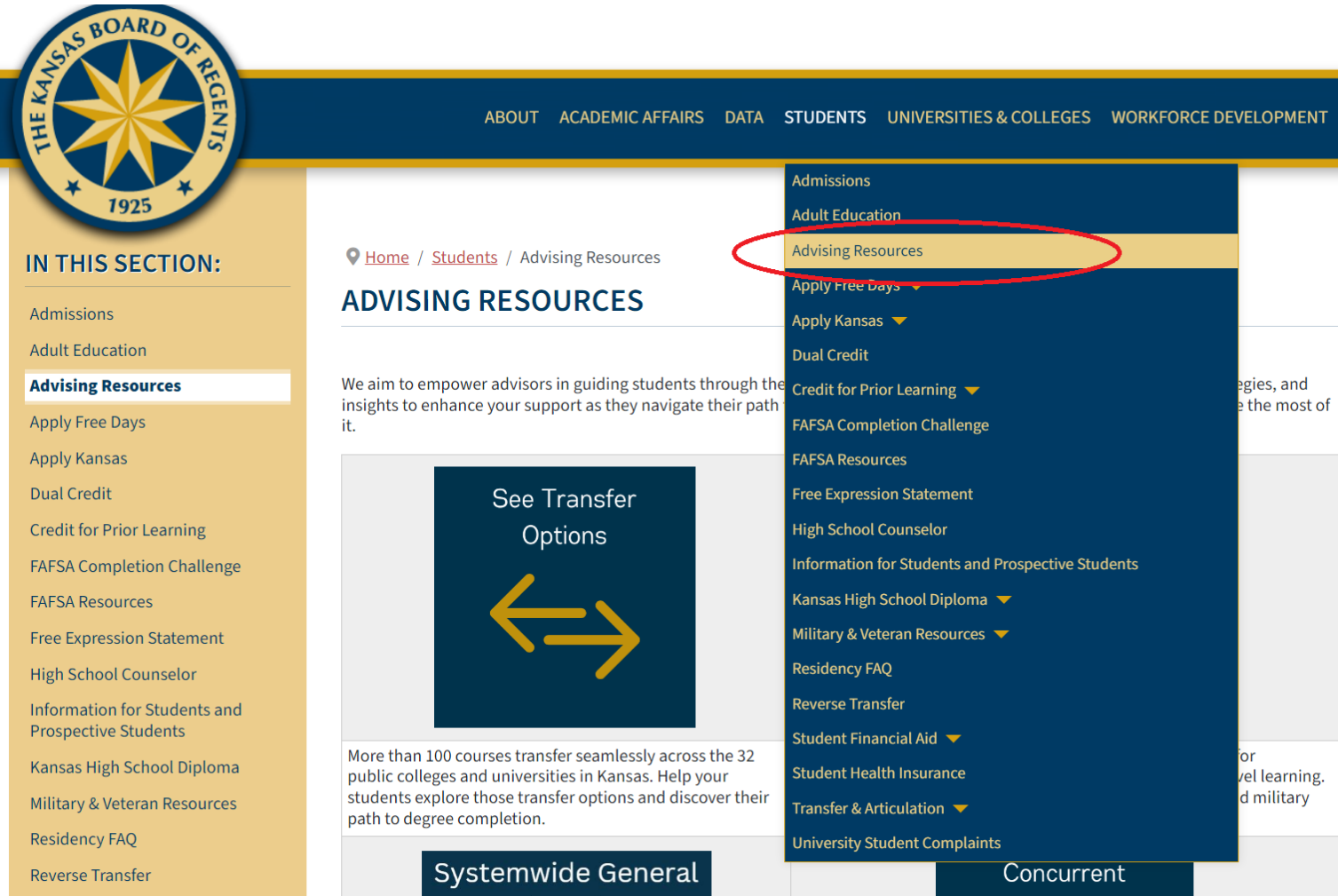
