Code of Conduct

Behavior that is expected and encouraged:

- Be respectful, inclusive, and accepting of others. Actively seek to challenge your personal biases, assumptions, and preconceived stereotypes, and approach differences with openness and curiosity.
- Be conscious of how your words and actions (including unintentional ones) might harm others. Take time to educate yourself on how to be more inclusive and listen when someone takes the time to educate you.
- Be aware of privilege and power dynamics. If you find you are talking or commenting a lot, consider stepping back to leave more space for others. If you share the work or ideas of others, give credit where it is due.
- Be considerate of privacy and personal boundaries. Give others a chance to "opt-in" to personal interactions, and respect limits when they are set.
- Be constructive in offering criticism and be gracious in accepting it. Consider "calling in" rather than "calling out," and direct critiques toward ideas rather than people.

Behavior that is strictly prohibited:

- Discrimination, including unfavorable or disparate treatment to others because of any aspect of their identity, appearance, or protected class.
- Harassment and harassing behavior, including use of epithets and slurs, derogatory or hostile comments, repeated attempts to make contact, or any behavior that interferes with another person's participation.
- Sexual harassment, including use of sexual images, jokes of a sexual or gendered nature, or any unwelcome contact of a sexual nature in any medium.

Reasons to Adapt an Open Textbook

- 1. Correct errors or inaccuracies
- 2. Update the book with current information
- 3. Add more media or links to other resources
- 4. Address diversity needs
- 5. Meet a cultural, regional, or national preference or information
- 6. Adjust for a different grade or course level
- 7. Address a particular teaching style or learning style
- 8. Make the material more accessible for people with disabilities



Is the content available under a license which allows for modification?

Copyright owners' exclusive rights:

- 1. Reproduce(copy)
- 2. Distribute
- 3. Publicly perform
- 4. Publicly display
- 5. Create derivative works (translations, revisions, and modifications)

Copyright is automatic and requires permission from the owner to use.

Fair Use


- 1. Purpose or character of the use
- 2. Nature of the work
- 3. Amount of the work
- 4. Effect on the potential market



Is the content available under a license which allows for modification?

Creative Commons Licenses - The author has flexibility and control of how their work will be used. The licenses allow

- Reuse
- Revise
- Remix
- Redistribute
- Retain



Attribution

Others can copy, distribute, display, perform and remix your work if they credit your name as requested by you

) No Derivative Works

Others can only copy, distribute, display or perform verbatim copies of your work



) Share Alike


Others can distribute your work only under a license identical to the one you have chosen for your work



Others can copy, distribute, display, perform or remix your work but for non-commercial purposes only.

How will you attribute the original OER?

- CC BY makes attribution mandatory.
- Elements: title of work used, author(s), and license type. Links are provided for the original work and license type.
- If you make changes, indicate that in the attribution statement.
- Place attribution statements at bottom of each chapter under "Attributions".
- Attributions page at the beginning of the textbook.
- Open Attribution Builder


