Approval of Minutes

Jill Arensdorf moved to approve the minutes from the December 17, 2025, meeting. Jesse Mendez seconded the motion, and it carried unanimously.

Council of Faculty Senate Presidents Update

Dr. Rochelle Rowley, Emporia State University's faculty senate president and Council of Faculty Senate Presidents (CoFSP) Chair, shared that the Council's current focus is on following legislative activities and review of the IB scores.

Second Readings

BS in Financial Forensics and Fraud Investigation

Jill Arensdorf introduced Jessica Heronemus-Claiborn, Instructor of Accounting at Fort Hays State University, who shared that this proposal will provide students with a solid foundation in criminal justice as well as business and accounting. It is designed to educate students on the financial aspects of fraud. She emphasized the high level of student interest in the program as well as support from stakeholders and partners.

Susan Bon moved to approve the proposal. Jesse Mendez seconded the motion, and it carried unanimously following discussion that highlighted the use of existing resources for this program.

Other Matters

Request to Approve Spoken English Language Competency policy

Director for Academic Affairs Sam Christy-Dangermond shared that the TOEFL iBT, which was previously scored on a scale of 1-30 will now be scored from 1-6. KU's Associate Vice Provost for International Affairs Roberta Pokphonh and Applied English Center Director Pam Pearson researched the new exam and recommended a minimum score of 4.5. She added that the old score requirements will still be maintained in policy for a while to prevent students from having to repeat the exam if they have already passed.

Barbara Bichelmeyer moved to move this item forward to BAASC for consideration. Jill Arensdorf seconded the motion, and it carried unanimously.
