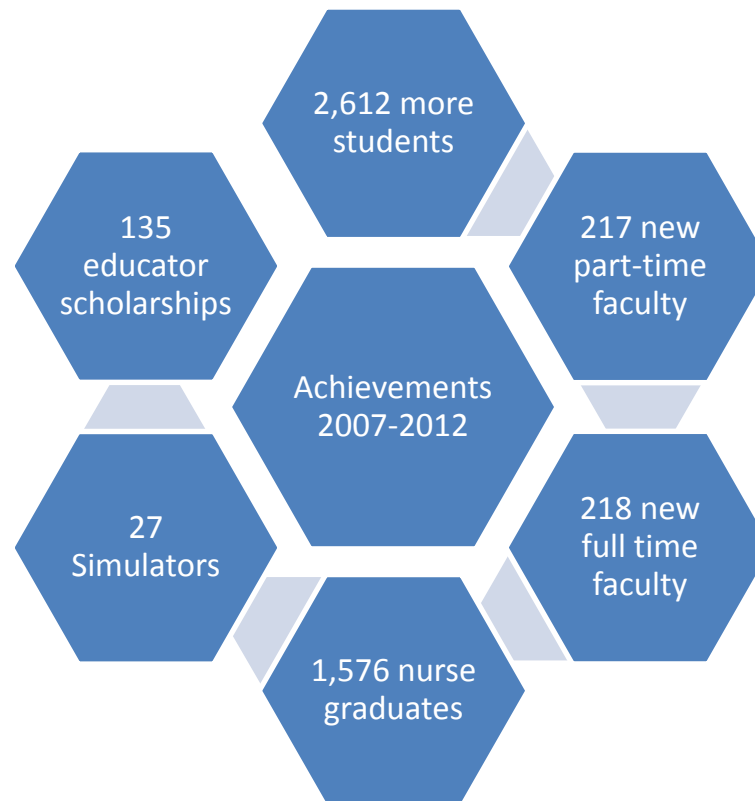

Continued Grant Funding

- ★ Annual Legislative Appropriation
 - No guarantee funds will be allocated each year so it cannot be taken for granted

- ★ All grant funds expended in year awarded
 - NO CARRYOVER!!



FY 2013 Process

- ★ Funds **must** be expended by June 30, 2013
(**NO** carryover funds allowed)
- ★ Any remaining funds must be returned or will be deducted from your final 20% allocation
- ★ Annual Report Due July 31, 2013

- ★ Final 20% of funds distributed after approval of Annual Report



Allowable Expenditures

- ★ Nursing Faculty Salaries
- ★ Consumable Classroom Supplies
- ★ Dollar for dollar match required for all funds
 - Report actual match amount even if it is over the requirement
- ★ Cannot report more grant dollars spent than awarded



FY 2014 Process

- ★ KBOR will contact Presidents requesting a Letter of Intent to participate in the 2014 Grant in July 2013 (example letter)

- ★ Estimated 2014 allocation letters distributed in August 2013
- ★ FY 2014 allocation expected to be approximately 1% less than FY 2013



FY 2014 Process

- ★ Participating institutions submit a Proposed Grant Funds Expenditures budget form

- ★ The full 80% of funds requested via email to Connie Beene cbeene@ksbor.org
- ★ Final 20% available after receipt and approval of Annual Report



New Annual Certification

- ★ Annual Certification for faculty paid by this grant
- ★ Beginning in FY 2014
- ★ Include Certifications with FY14 Annual Report
