The February 12, 2025, meeting of the System Council of Chief Academic Officers was called to order by Luke Dowell at 8:30 a.m. The meeting was held virtually through Zoom.

### **APPROVAL OF MINUTES**

Jill Arensdorf moved that the minutes of the January 15, 2025, meeting be approved. Following the second of Susan Bon, the motion carried unanimously.

### SYSTEMWIDE UPDATES

### FIRST 15 UPDATE

Vice President for Academic Affairs Rusty Monhollon shared that the working group met on January 21 and February 6. Although consideration was given to pilot the program with English Composition I, discussions about funding and other concerns brought the decision to a standstill. The group has requested further data to address the concerns raised at the February meeting before moving forward.

# RECEIVE ANNUAL REPORT ON APPLY KANSAS APPLICATION CAMPAIGN, RECEIVE REPORT ON KANSAS FREE APPLICATIONS DAY, AND RECEIVE REPORT ON KANSAS FREE APPLICATIONS DAY FOR 2025-2026 ACADEMIC YEAR

Associate Director of Academic Affairs Mistie Knox presented the Apply Kansas Application Campaign annual report. She reported that 89% of Kansas school districts participated in Apply Kansas for 2024, with 22,818 applications submitted. She also shared the report on Kansas Free Applications Day, noting that applications submitted during the Apply Free Days increased by 76% from 2023 to 2024, totaling 17,471 applications submitted to public institutions. A proposal to continue Apply Free Days for the 2025 academic year will be presented to BAASC and then to the Board.

### **OTHER MATTERS**

### ACADEMIC AFFAIRS UPDATES

Vice President Monhollon shared that about two-thirds of registrants attended the Complete College America (CCA) Alliance Launch event held on February 11 at Washburn University. There was great feedback about the presentation and the group discussions.

Director of Academic Affairs Sam Christy-Dangermond shared updates on the professional development sessions. The final session for math faculty was held on January 24. Brandon Protas from Complete College America (CCA) presented on assessing student success in corequisite supports for math and English courses. The most recent session for English faculty was held on January 31. Kathy McCoskey of Butler CC, Dr. Melanie Burdick of Washburn University, and Dr. Casey Reid, formerly with KU, presented on reading supports for English, scaffolding, and integrating reading and the reading cycle into the teaching of writing. The next English faculty professional development session is scheduled for February 28.

# **Reverse Transfer Annual Report**

### Summary

Reverse transfer enables students to transfer credits earned at a university back to a community college to complete an associate degree. The Kansas Board of Regents implemented the systemwide Reverse Transfer Agreement in 2014, with policies ensuring compliance with legal, policy, and accreditation standards. Recent updates to the process include a proposed adoption of the National Student Clearinghouse's free data exchange service in fall 2025. The Reverse Transfer Working Group continues to optimize strategies to ensure students receive credentials they have earned.

# Background

Reverse transfer facilitates the transfer of credit hours earned at a state university back to a state community college for students who transferred without completing the requirements for an associate degree. This allows students to fulfill remaining requirements at the community college and be awarded the associate degree by that institution.

The Kansas Board of Regents first approved reverse transfer agreements in 2014, codified in the Board Policy Manual, Chapter III, Section A.3. The policy directs the "state universities, community colleges, technical colleges, Washburn University and Washburn Institute of Technology to work together, through the System Council of Presidents and System Council of Chief Academic Officers, to develop a process to assist students to complete coursework for and attain all certificates and degrees for which they are eligible." The process and reverse transfer agreements shall:

- a. Be consistent with state and federal law, Board policies and applicable accreditation standards;
- b. Provide a mechanism for each student who is transferring credits from a community college or technical college to a university to participate in the reverse transfer process; the established mechanism shall include an opportunity for each otherwise eligible student to opt-in to the process, thereby permitting sharing of that student's Family Educational Rights and Privacy Act protected information; and
- c. Provide guidelines for determining which transferring institution will award the credential if the student has transfer credits from more than one institution.

In May 2014, the presidents and chancellors of all state universities, community colleges, and technical colleges signed the systemwide Reverse Transfer Agreement, which took effect the following fall. At this time, the Reverse Transfer Working Group was formed to review and revise procedures and recommend them for approval by the System Council of Presidents and System Council of Chief Academic Officers.

The System Council of Presidents and the System Council of Chief Academic Officers last approved the systemwide "Reverse Transfer Procedures," on September 18, 2024. The full text of the document is available here: <u>https://www.kansasregents.org/academic\_affairs/reverse-transfer</u>

The most recent updates to the Reverse Transfer Procedures are scheduled for approval at the December 18, 2024, meetings of the System Council of Presidents and the System Council of Chief Academic Officers. These updates include the addition of language supporting the use of the National Student Clearinghouse's free data exchange service, which is set to begin in fall 2025.

In 2018, KBOR staff developed a "Reverse Transfer Communication Plan" to assist institutional staff in promoting reverse transfer, which includes visual aids to assist in communicating about reverse transfer (see below).



### **Reverse Transfer Procedures**

The systemwide reverse transfer procedures require universities to identify transfer students with 60 credit hours completed at one or more colleges. Upon identifying those students, universities inform students about reverse transfer and give students a choice to opt into the process. Once a student opts in, their transcript data is sent to the appropriate two-year institution each fall and spring until the student earns an associate degree, graduates, opts out, or is no longer enrolled.

# **Reverse Transfer Working Group**

Reverse Transfer Working Group (RTWG) has been meeting consistently to monitor and optimize reverse transfer strategies to ensure students acquire credentials that they have earned. The members of the Working Group are listed below.
